All the Mandal Educational Officers/Deputy Inspector of schools and Deputy Educational Officers in the district are invited to the reference cited, the Commissioner of School Education, Andhrapradesh, Amaravathi has informed that the Hon'ble Chief Minister of AndhrPradesh, has reviewed in the meeting on 23.07.2018 regarding MGNREG Scheme with the line Dept. HODs in the state are directed to issues instruction to all concerned and ensured that action is taken.

- 1. Every Saturday, the students and employees are to participate in cleaning of the School premises of all the schools/Colleges/Officer under the Swachha Andhra Pradesh programme.
- 2. To remove the garbage, screw trees ,scrap material in the school premises
- 3. To arrange the "Nutri Garden " in every school in the state and rise the Vegetable plants with involvement of students. The needed saplings are to be collect from the Horticulture Dept., in the districts. The vegetables from the Nutria gardens are to be utilized in school Mid Day Meal to add nutrition's value.
- 4. The Head masters may also coordinate with the Gram Panchyat Nutri gardens to grow or obtain fresh vegetables for Mid Day Meal.
- 5. To speed up the progress for construction of compound walls (314+503=817 schools) Under MGNREG and to review with the Project Officer, SSA and PD,DWAMA.

- 6. Where the school buildings are in dilapidated condition in the school premises, those are to be demolished under the MGNREG scheme funds. The approvals may be obtained from the District Collector.
- 7. To conduct a special drive to clear stagnant rain water in school premises, a week beginning from Tuesday ,29.07.2018.

In view of the above, All the Mandal Educational Officers/Deputy Inspector of schools and Deputy Educational Officers in the district are directed to give necessary instructions strictly to all the Headmasters of Primary/Upper Primary and High schools in your jurisdiction to follow the above instructs scrupulously. And action taken copy extended to this office through mail for onward submission of the same to the Commissioner of School Education, A.P., Amaravathi for taking further course of action in the matter
